Defence Procurement that he had instructed MOD officials to engage with the Community Council to transfer the ownership of the 2.6 hectare sports field to the Council, in addition to the playground. MOD officials have been instructed to find a way of ensuring the land is sold to the Community Council. He also confirmed that officials were to draw up a temporary tenancy arrangement in order to allow sporting fixtures to be held on the field until the sale was able to progress. Ben Lake is chasing this up.

One Voice Wales legal advice is that as a community council we do not have powers of compulsory purchase. John Jones MOD has written to the legal department at Ceredigion County Council.

Clerk has requested advice from John Jones on the situation regarding the purchase of the land and his email response provides reassurance that the MOD are working towards a private treaty sale to the community council. (10)

Cllr Robin Young felt that it was important to keep close contact with Ben Lake on this.

Cllr Gethin Davies advised that Ben Lake is due to meet with Ceredigion County Council to discuss the purchase. The Clerk and Cllr Sue Lewis both have concerns regarding the County Council purchasing the land on behalf of the community council and subsequently leasing it to us; this could potentially hinder grant applications.

Email received from Mr A James advising the community council of issues regarding heating pipes wrapped in asbestos running in concrete tunnels in the football field and play area. It was agreed that the Clerk would clarify this with Mr John Jones

Aberporth Football Club contacted the press about being unable to use the football field. MOD have responded. There is still no update regarding the lease at ths time.

Cllr Anne McCreary had received a request for a memorial bench via the village hall management committee. Clerk recommended replacing an old concrete seat at lower welfare park. Cllr Gethin Davies agreed that this bench does need some work, it is currently unsafe and will require lowering, a new slab and new seat; the bank needs to be retained. Cllr McCreary to contact the relevant parties and advise them of this option.

Civil Contingencies Section of Ceredigion County Council is undertaking a small survey to identify local Community Venues which could possibly act as Rest Centres during an emergency.

Cllr Anne McCreary advised that there is an existing emergency plan for Aberporth which needs to be included in the strategy. The existing plan includes the village hall as a location so it needs updating and suggested Canolfan Dyffryn and Chapel hall at Blaenannerch as rest centre locations. Cllr Anne McCreary is to follow this up.
